FOMRE deputation to the Statutory Planning Committee

In our October 2018 newsletter we told you that Moore River Company had applied to the WA Planning Commission for a renewal of the 2014 subdivision approval for their development at Moore River South. FOMRE chose to challenge this. Our reasoning (apart from it being a bad idea): plans from the early 2000s, based on field surveys from the 1990s, should not be revised and approved in the light of the State's current planning policies.

In November both the MRC and FOMRE made deputations to the Statutory Planning Committee (SPC). Following a verbal and video presentation, the committee received FOMRE's written summary of objections. (*Attached* – a good read, or visit https://guildertonwa.com.au/news-flashes)

The Result? A decision not to make a decision! In the light of current planning directives the SPC tabled its decision to seek advice from the State Solicitor's Office. FOMRE judged this is a step in the right direction. FOMRE will now maintain a watching brief, consult those adept with the legal planning environment and will inform you of further developments.

A Reiteration:

- That common sense and the application of current contemporary planning policies are applied to this unique Western Australian treasure:
 - o 100 km north of Perth,
 - o appreciated by thousands,
 - o fundamental to the Yued nation legacy, and
 - o the one estuary on the Swan Coastal Plain that remains close to its natural state.
- The creation of a suburb outside Perth's metropolitan area, in a
 - o cul-de-sac,
 - o fire prone,
 - o employment-absent and
 - o infrastructure –free location is extremely unwise.
- Further effort should be exerted to concentrate on protecting this asset for all and future Australians and cease both financial and time wasting of all parties.
- FOMRE maintains that the estuary will be an asset as valued by the people of Perth and its regions as much as they now value King's Park. The sooner the land south of the estuary is brought into public ownership ... the sooner the estuary's future will be assured.'
