1. NOW An invitation to FOMRE's AGM.

Notification of 2016 Annual General Meeting Saturday April 23rd 2016 Guilderton Community Hall @ 10.00

You are invited to attend FOMRE's 2016 Annual General. Please support us as we continue to champion the long term health and wellbeing of the Moore River Estuary. Your support remains as vital as it ever was as we maintain an active watching brief on the future of the estuary.

2. & NOW Perth and Peel Green Growth Plan for 3.5 million (GGP3.5) FOMRE Response and call for public submissions. Public comment is open to 13th May 2016

WA has recently been presented with a unique and precious opportunity to protect and formally resolve the land use conflict on south side of Moore River estuary. Please read on.

The residents of Perth are being asked to comment on a game changing proposal that will affect the quality of our lifestyle here in Perth for the next 30 years. The environment within which we live is currently being determined by the Australian and Western Australian Governments with the release of its draft *Perth and Peel Green Growth Plan for 3.5 million* (GGP3.5). The *GGP3.5* will **replace** project-by-project EPBC assessments of

development proposals – if a development fits within the acceptable actions of the Strategic Assessment, it will not be further assessed under the EPBC Act. At its centre the *GGP3.5* is a Strategic Conservation Plan; identifying what will be done to protect the Matters of National Environmental Significance, regional threatened species, Ramsar wetlands and such like.

Two very important components that FOMRE can address in these documents are:

- Carnaby Cockatoo conservation and
- The impact of the plan on the Moore River Estuary (MRE) at the northern most point of the Strategic Assessment Area (SAA).

While the GGP3.5 deals with the Swan and Peel Rivers, the southern bank of the Moore River lies on the northern portion of the Swan Coastal plain. Taking its proximity to Perth and the northern strategic assessment areas into consideration it would be an apposite step to finalise the northern boundary up to the south side of the Moore River.

An opportune moment to extend the scope of the Green Growth Plan by 1 -2 km north currently exists. In April 2016 the property that is currently owned by the Moore River Company (MRC) has been recently (2015) placed onto the market (with limited or no expressions of interest proffered).

By acquiring the land owned by Moore River Company it would then be added to the important northern conservation areas of Perth metropolitan area including Wilbinga Conservation Park (Due to the large size and continuity of these lands they have been identified as being fundamental in the success of the *GGP3.5*) our fractious and protracted controversy <u>would be resolved to the satisfaction to all concerned</u>.

To this end FOMRE has prepared a response to the *GGP3.5* and is to be found on our website. <u>www.savemooreriver.org</u>

It is also important to note that the draft paper does not consider the effects of proposed draft Green Growth Plan's Conservation Program (Action Plan H) on the species, including the establishment and management of new conservation reserves, revegetation initiatives and breeding enhancement programs.)

<u>guilderton</u>) As you are all aware optimising the health of Moore River estuary is at the forefront of FOMRE's commitment. Petitions, submissions and deputations have been a major component of our hard work. However actual on ground activities are also an essential component of our remit.

A good news story is FOMRE is participating in a new citizen science project that aims to monitor water quality of the estuary. With encouragement by FOMRE, the Northern Agricultural Catchments Council NACC successfully sought funding through Lotterywest to purchase the necessary water quality meter, and also developed a comprehensive sampling and analysis plan. In October last year, FOMRE members and NACC undertook water monitoring training with Department of Water staff in preparation for the start of regular monitoring. Samples will be collected four times per year from five sites along the estuary.

An inspiring article *People + Passion = healthy Estuaries at Guilderton* is provided in the NACC enewsletter. Please take the time to read visit this site as it is full of interesting news pertaining to the area we value so highly.

5. VERY GOOD NEWS - www.savemooreriver.org is active!

Recently FOMRE, Guilderton Community Association and the Guilderton Visitor Centre put their heads together and revitalised our website. We recognised that the previous one was not performing as well (plus it had been hacked badly by spammers). Thus we sought assistance from *OM4*, a local web design and development company, to create an attractive and relevant website. We encourage you to have a look, comment and contribute. 6. NOT SO GOOD NEWS- 4WD vandalism http://www.gingin.wa.gov.au

A very fast way of destroying habitat is for it to be driven over. Vegetation is damaged, wheel ruts become indelible and attract other would-be drivers, soil is compacted or alternatively the soil crust is disturbed and then blown or washed away. Weeds, Dieback and litter accompany such behaviours. Worse yet it is potentially dangerous to people using the beaches (or driving the vehicles). Unfortunately in recent times there has been an increase in off road vehicles visiting Guilderton beach and driving on 'The Desert'. FOMRE has reported several of these infractions to the Shire of Gingin and the Moore River Company. The 4WD problem is markedly less since a meeting in December between Department of Parks and Wildlife, the Shire of Gingin Moore River Company and the Guilderton Community Association. The following was inserted in the December *Moore River News:*

4WDs, Trail Bikes and Dune Buggies at Guilderton.

Guilderton town and the land at Moore River South is surrounded by beautiful bush that is well worth protecting. Recent invasions of off-road vehicles are currently threatening this bush in many places.

Simply put, no vehicles are allowed on the beach or foreshore within 2.6kms south of the groyne.

They are also prohibited on private land, the river foreshore and the Reserve.

This means that vehicles entering at Wilbinga may not come north, and that no vehicles should ever be seen from the upper lookout or on the river foreshore.

North of the groyne vehicles may access the beach and there is an unmaintained 4WD track to Seabird. Other areas have been fenced off while we revegetate them. Please stay on the tracks. The Moore River Estuary gets very busy in summer with visitors. We ask all recreational vehicle drivers to be sure to only go to designated off-road areas. These are mainly at Lancelin.


7. EXTREMELY GOOD NEWS Beautiful Beach

http://ginginwater.org.au Upstream from the Moore River Estuary is the Gingin Brook. Its waters significantly contribute to the Moore River. Over the past 4-5 years a group of concerned

citizens have endeavoured to understand and track the way the Department of Water (DOW) controls the use of water within the ground and surface systems across the Gingin region. The Gingin Water Group is made up of a concerned group of local farmers who have observed the reduction in summer flows in Gingin Brook, bores that have produced water for decades drying up and the water level in many others falling rapidly. Their website provides for a host of information pertaining to water quality and monitoring.
